Legal basis: Article 70 Paragraph 1 of the Act on public offering – acquisition or disposal of a substantial package of shares

Decrease of the number of shares held by Pioneer Pekao Investment Management S.A. to less than 5% of total equity

The Management Board of AB SA, pursuant to Article 69 Paragraph 1 and Article 87 Paragraphs 1 and 2, and with regard to Article 88 Paragraph 2 of the Act on public offering and the terms of introduction of financial instruments to the trading system as well as on public companies of July 29, 2005 (Journal of Laws No. 184 Item 1539 as amended) informs that on March 15, 2010 the Management Board was notified by Pioneer Pekao Investment Management S.A. (the Investor) of the reduction of the number of shares held by the mutual funds managed by the Investor to 4.52% of votes in the General Meeting of Shareholders AB SA.
