

## Current Report No. 11/2010

*Legal basis: Article 56 Paragraph 1 Item 2 of the Act on public offering – current and interim reporting*

### Court registration of an equity increase

The Management Board of AB S.A. with its seat in Wrocław (the Issuer), pursuant to Article 5 Paragraph 1 Item 9) of the Ordinance of the Minister of Finance on current and periodical information disclosed by issuers of securities dated February 19, 2009 (Journal of Laws No. 33 Item 259) informs that on May 26, 2010 the Issuer was delivered the decision of the District Court for Wrocław-Fabryczna in Wrocław, VI Business Division of the National Court Register (the “Registry Court”), dated May 18, 2010 on registration of the increase in the Issuer’s equity, from PLN 16 026 002 to PLN 16 295 002. The equity was increased as a result of an issue of 269 000 shares of series G at par value of PLN 1 each.

The issue of shares was executed in compliance with the Resolution No. 20/2006 of the Extraordinary General Meeting of May 30, 2006 concerning the incentive scheme designed for the members of management.

Following registration of the equity increase, the total number of votes resulting from all shares of AB S.A. issued is 17 608 002, and the equity structure is as follows:
